### **Health and Insurance**

All exchange students should have a valid health insurance. Also, it is needed to apply for the residence permit. One of the following insurances is accepted:

1. A document confirming that you can benefit from the medical services in Turkey based on a Bilateral Agreement signed between the two countries concerning the Social Security (If Turkey and your home country has a social security agreement, visit the social security body in your country to get a document called formular and further information. After your arrival in Turkey, have this document approved by Turkish Social Security Office. You can use this approved formular as your insurance)

Private General Health Insurance should be issued in Turkish language and should include the following statement in Turkish language "This policy covers the minimum coverage stipulated in the circular no 9, dated 06/06/2014, on private health insurance required to be taken out for residence permit applications."

- 4. Notification letter: if you do not have a valid health insurance, please sign the notification letter (to be obtained from YTU EU Office) as a commitment that you'll apply to Turkish Social Security Institution within 3 months after your arrival in Turkey.

#### **Residence Permit**

As a student, you are obliged to apply for a valid residence permit in the Republic of Turkey, to the Directorate General of Immigration Management (Göç İdaresi Genel Müdürlüğü). You will make the permission application for residence after you arrive in Turkey and your document will be sent to the address you stated in your application.

The residence permit application is made in two steps:

- 1. Online application (within 30 days after your arrival)
- 2. Submission of documents to the Immigration Management Office: (You will go to the Immigration management office on the day of appointment along with the required documents!)

#### **How to Make the Online Application**

- Before starting your application make sure that:
- You have a passport valid at least 60 days longer than your Erasmus stay
- Your health insurance should cover your Erasmus stay
- 1. Visit: <a href="https://e-ikamet.goc.gov.tr">https://e-ikamet.goc.gov.tr</a>
- 2. Select: First Application
- 3. Fill the pre-registration form
- 4. According to your communication preference, a verification code will be sent to you. In order to continue your residence permit application, you must enter this verification code.
- 5. Choose "student resident permit application"
- 6. Fill out the form and do not forget to upload your photo.

  - Save and print the document
  - Keep this document to submit to the Immigration Management Officers

#### Card Fee & Tax Number

In order to pay the fee for residence permit (app. 63 TL), you should take a tax number from "Gelir İdaresi Başkanlığı" (Revenue Administration Directorate) with your passport and passport copy, and then you can make your payment in the same building to the Pay desk. Keep the fee receipt to submit the migration officers.
